Kureha Corporation has resolved at its board of directors meeting held today to pay the following dividend (FY2019 interim dividend) to shareholders of record September 30, 2019.

2. Reasons

Kureha's basic policy regarding dividend distribution is to pay a steady dividend to shareholders over a long period of time, while strengthening the company's financial structure to sustain long-term growth and future business development. From this standpoint, Kureha has determined to pay its shareholders 85 yen per share, as forecasted in August 2019, for the interim dividend of fiscal 2019.
